A complete set of rules will be sent to all members as nominations are received.

NEVADA STATE PAINT HORSE COORDINATING COMMITTEE
NSCC GUIDELINES 2006

THE SILVER STATE PAINT HORSE CLUB IS NO LONGER A MEMBER CLUB OF THE NSCC. NO SHOWS SPONSORED BY SSPHC WILL BE APPROVED NOR WILL ANY POINTS BE ACCEPTED FROM THEIR SHOWS.

It is the clubs responsibility to have the show secretary send a complete copy of results to the NSCC point keeper so that points for awards can be processed.

EXCEPTION: It will be the owners/exhibitors responsibility to send in their show bill/receipt from the Eastern Nevada Paint Horse Club 4 Judge which will be held in Las Vegas the end of October 2006. This must be received by the point keeper within 10 days after the show ends. The SSPHC portion of the show is not approved and does not count for points. The 10 days to get your points in will start counting down after the ENPHC portion of the show is concluded.

Any individual will be recognized as a member of NSCC upon nominating a horse and becoming a member of ENPHC or NPHC.

NSCC STATE AWARDS PROGRAM YEAR END AWARDS

Eligibility:

- 1. All horses must be registered with APHA. Weanlings may show as pending but a copy of said weanlings registration papers must be submitted to the point keeper by Nov. 1st of the current year or owner could be deemed not eligible due to failure to comply with rules.**
- 2. Owner must be a current paid member in good standings with ENPHC or NPHC.**
- 3. All outstanding debts must be paid before October 31 of the current year. Failure to do so will result in the loss of any pending awards.**
- 4. To be eligible for awards, a horse must be nominated and the \$10.00 per horse paid by April 29th. Horses must show under 12 judges out of the 22 approved judges/shows. (Clarification: Horse must "qualify" in any given class under 12 judges. However, all judges/shows will count once you have qualified in any said class under 12 judges. ONLY classes in which horse has "qualified" will be totaled for ANY special awards listed below under Special Awards.**
- 5. Horse must have accumulated a total of 6 points to qualify for any class awards.**

If you have met the 12 judge requirement but have failed to accumulate at least 6 points, the horse will be disqualified. This pertains to Special Awards also.

Youth/Amateur/Novice Amateur

- 1. Points will be tallied on the basis of one horse/one rider combination for all awards.**
- 2. Amateur/Novice Amateur must have a current APHA Amateur/Novice Amateur Card or apply for one from show secretary.**

Sr. Performance Horse Jr. Performance Horse Hi Pt Youth 14-18

Hi Point Novice Youth Awards to all lead line

To qualify for special awards listed above, horses must show in 2 categories of performance as listed in the current APHA rule book. Open to show in open; youth in youth; Amateur in Amateur, Novice Amateur and Novice Youth in specified classes.

If you need a point tabulation charts to track your own points, there is one in the NPHC 2006 Directory and also one located in the 2006 California Paint Horse Directory.
