All owners and exhibitors need to be familiar with the NPHC Rules & Guidelines for 2018. Please read the rules below and refer to the 2018 NPHC Year-end Awards rules for qualifications and requirements.

**SPB:** Refers to **Solid Paint Bred - Breeding Stock**

**\* NPHC All Breed and Walk/Trot Class Numbers 113, 114, 122, 129, 136, 142, 210, 221, 233, 240, 247, 318, 408, 410, 412, 413, 429, 430, & 450** are OPEN BREED classes for any and all horses/exhibitors. These classes are not APHA APPROVED. Non-Paint registered horses may not enter any other APHA Paint or SPB class at our shows. NPHC and/or APHA membership is encouraged, but not required to participate in open classes. NPHC membership is required for participation in the year-end awards program. Walk/Trot exhibitors may not enter in any three gaited class at this show. In addition, these exhibitors should not enter in any three gaited class at any other APHA breed level show. **Exhibitors can show either 113 or 114 but not both.** **Additionally, exhibitors showing classes 113, 114, or 115 cannot enter classes 116 or 117 per APHA rules.**

**\*\* Class Numbers 319, 414, 431, & 451:** If applicable, the NPHC All Breed and Walk/Trot Class rules and requirements listed above also apply to the NPHC Green Rider/Handler classes. Additionally, the NPHC Green Rider/Handler classes are open to regular and solid paint bred registered horses and to any exhibitor provided he/she will follow APHA Green Horse rules and earned point regulations. Refer to the 2018 APHA rulebook for qualification guidelines. Any exhibitor that points out in a specific class in a calendar year will be allowed to compete in that Green Handler/Rider class for the rest of the year. NPHC and/or APHA membership is encouraged, but not required to participate in open classes. NPHC membership is required for participation in the year-end awards program. Exhibitors in this division are not required to own their horses. These classes are not APHA APPROVED.
