Registration: All horses must be registered with the American Paint Horse Association, except current year foals, which must be shown as unnamed. All registered owners of horses being shown must have a current APHA membership card and a copy needs to be included with the papers.

Send entries and a photocopy of Horse papers plus Owner's Membership, Exhibitor's Membership, Youth, Amateur, and Broodmare cards, if applicable, to the Show Secretary. *All owners and exhibitors must have a current APHA membership card in addition to Novice Amateur, Amateur, Amateur Walk-Trot, Youth, and Novice Youth. All necessary temporary cards and memberships are available from the show secretary at the show, with APHA's Additional Rush fee added. <u>APHA forms require separate payment.</u>

Horses must be pre-entered with at least one entry per horse, or a post entry fee of \$25.00 will be charged.

You are responsible for knowing all the APHA rules AND the NPHC rules that pertain to classes, showing, and qualifying for awards offered by all organizations approving this show.

NPHC 2-5 and APHA Leadline classes are free, BUT exhibitors are responsible for paying associated fees that pertain to all organizations approving this show.
