Currently have a total balance of \$18,334.00 which includes (2) \$5000.00 CD's, \$166.00 Youth Scholarship Fund and \$8,168.00 in the bank. This total includes some of the stall fees from the July 30th show but not all, and of course, none of the show proceeds. However, all of the motel fees and most of the air fares have already been paid for the remaining shows/judges so it looks like we should have a good year. Motion to approve the report, passed.

It was announced that Kassi Venturacci will be the recipient of the NPHC scholarship award for this year, to a round of applause from all in attendance. Kassi is a new youth member of NPHC and although not active in horseshows she has been an active participant on the high school rodeo team having earned the all around champion title at several events. Congratulations Kassi!!

Gwen Russell will take over the Directors position held by Jennifer Afill, due to the fact that Jennifer didn't join the club this year, and one of the requirements for being a Director is membership in the club, per Article III of the By-Laws.

Sharon Avery brought up the subject of stall rentals for our shows. It seems that over 50% of the stalls are reserved for the up coming POR show in August, so she encouraged everyone to get their payments in if they were going to require stalls. Also, in the future, if you reserve stalls and can't make the show, you must call at least 3 days in advance to cancel or you will be charged for the stalls. Sharon has been turning people away only to find that there are empty stalls on the day of the show. It only takes a phone call and it could save you some money. ***NEWS FLASH, as of 8-2-05 there are no stalls available, however there are about 20 outside covered pens still available so be sure to call Sharon NOW if you need one, they won't last long.
