Must show under 8 Judges in each class of which 2 Judges are from a NPHC 2 Judge show.(All other NPHC rules apply)

A proposed amendment to the NPHC by-laws was read. It was signed by the required 5 members: Gary Avery, Summer Mason, Kerri Ruby, Shirley Ruby, and David Ruby.

"We, the members of NPHC listed on this proposal, do hereby propose that the by-laws be amended as follows: Article VIII Section 2: This clubs books of account be audited at least once a year, no later than December 31. The Board of Directors shall name the auditors.

**Reason for Amendment: To have the accounts of NPHC audited during the off season as well as aligning the audit of the accounts to be on the same time frame as our fiscal year.** 

The current audit takes place half way through the year(July 31<sup>st</sup>) with 2 shows held prior and 2 shows held after the current audit date. This amendment will be voted on at the general membership meeting in

February.
