This pertains to meeting the # of times shown in a class for year-end awards. No points to be awarded.

A motion was made by Dave Ruby and 2nd by Dave Ragsdale that Suzi Jarboe be in charge of the sign in sheets at the meetings. Motion carried. It will be your responsibility to get signed in, as the sheet will no longer be passed around. Each member must sign in as signing in for another member is not permitted.

In the case of tack or rider changes, it is the responsibility of the riders to notify the gate person.

A motion was made by Kerri Ruby to combine the Amateur classes back to all ages. Motion was 2nd by Melanie Ragsdale. Motion carried.

A clarification was made that year-end awards would be given to Champion and Reserve as well as 3rd thru 6th. (Subject to approval by NPHC Board of Directors)
