**Registration:** All horses must be registered with the American Paint Horse Association, except current year foals, which must be shown as unnamed. All registered owners of horses being shown must have a current APHA membership card and a copy needs to be included with the papers.

Send entries and a photocopy of Horse papers plus Owner's Membership, Exhibitor's Membership, Youth, Amateur, and Broodmare cards, if applicable, to the Show Secretary. **\*All owners and exhibitors must have a current APHA membership card in addition to Novice Amateur, Amateur, Amateur Walk-Trot, Youth, and Novice Youth. All necessary temporary cards and memberships are available from the show secretary at the show, with APHA's Additional Rush fee added. APHA forms require separate payment.**

**Horses must be pre-entered with at least one entry per horse, or a post entry fee of \$25.00 will be charged.**

**You are responsible for knowing all the APHA rules AND the NPHC rules that pertain to classes, showing, and qualifying for awards offered by all organizations approving this show.**

**NPHC 2-5 and APHA Leadline classes are free, BUT exhibitors are responsible for paying associated fees that pertain to all organizations approving this show.**
